Raffle License Rules & Regulations

Ordinance 2002-17

1. No person, firm, or corporation shall conduct a raffle within the Village of Gurnee without first obtaining a license from the Village.
2. Licenses for raffles shall be issued only to bona fide religious, charitable, labor, business, fraternal, educational or veteran's organizations that operate without profit to their members and which have been in existence continuously for a period of five (5) years immediately before making application for a license and which have had during their entire five-year period a bona fide membership engaged in carrying out their objectives, or to a nonprofit fundraising organization that the Village determines is organized for the sole purpose of providing financial assistance to an identified individual or group of individuals suffering extreme financial hardship as the result of an illness, disability, accident, or disaster.
3. The expiration date for each license will be one hundred twenty (120) days after the issuing of the raffle license.
4. No person or organization connected to individuals who have been convicted of a felony and/or are or have been a professional gambler or gambling promoter will be issued a raffle license.
5. The aggregate retail value of all prizes or merchandise awarded in a single raffle is limited to \$250,000.
6. The maximum retail value of each prize awarded in a single raffle is limited to \$200,000.
7. The maximum price which may be charged for each raffle chance issued or sold is limited to \$100.
8. Applications shall be made in writing through the Village Clerk's office at least thirty (30) days prior to the first day intended for sale of the raffle chances. The application shall be on a form furnished by the Village Clerk.
9. The manager of the raffle shall give a fidelity bond in the sum of the total value of the prizes to be awarded in the raffle conditioned upon his/her honesty in the performance of his/her duties.
10. All raffles must adhere to the rules of Ordinance 2002-17.
