#### E. REPORTS

Mr. Muetz said Chief Woodside has a follow-up report to present to the Board about a complaint from the February 20<sup>th</sup> regular meeting regarding commercial trucks parking overnight at the Sams Club and/or Walmart parking lots.

Chief Woodside said at the February 20th regular meeting there was a complaint about a semi-truck parked overnight in the Sam's parking lot. He said that the Village Board had passed Ordinance 2006-67 which approved an agreement between the Village and the property managers in which the Police Department agreed to regular after hours parking on those properties. However, the ordinance does allow store managers to approve overnight parking for specific trucks. He said after contacting Wal-Mart this semi-truck was granted permission to park overnight by management.

### Kevin Moss 2086 Windsong Ct

Mr. Moss stated that, according to Ordinance 2006-76, the overnight parking of commercial semi-trucks, buses, etc. was prohibited.

Mayor Kovarik said both managers at this location would like the Village to rescind this ordinance. She further stated that, according to the ordinance, the managers have the ability to allow overnight parking at their discretion. She continued by saying that management lets the Police Department know if they have a problem, and that the Village cannot pull police officers out of neighborhoods to patrol parking lots.

Mr. Moss asked Chief Woodside if he reviewed the video that Mr. Moss alluded to at the February  $20^{\text{th}}$  meeting.

Chief Woodside said he did not.
