Waiver of Liability

The undersigned person holds a special interest in community affairs and in particular, the problems and process dealing with law enforcement.

WHEREAS, the Gurnee Police Department is a municipal law enforcement agency and continually operates in an environment which is representative of a metropolitan suburban area, and;

WHEREAS, the Village of Gurnee, an Illinois municipal corporation, is willing to allow the undersigned to accompany members of the Gurnee Police Department in the carrying out of official police duties, provided that the Village will not thereby incur the risk of any liabilities to the undersigned, or to any third party by virtue of actions of the undersigned, and;

WHEREAS, the undersigned acknowledges the dangers and agrees to assume the aforesaid risks involved in accompanying Gurnee Police Officers while carrying out official duties, on the terms hereinafter set forth;

NOW, THEREFORE, in consideration of the Village of Gurnee in allowing the undersigned to accompany police officers in the carrying out of official duties as police officers, and in order to induce the Village of Gurnee to permit such activities, the undersigned agrees to indemnify, defend and hold harmless the Village of Gurnee against any and all loss, liability, damage, claims, costs and expenses which it may hereafter suffer, incur, be put to or pay out as result of the undersigned being present with any Gurnee Police Officer in the conducting of official duties, and further hereby releases and covenants and agrees not to sue the Village of Gurnee or any of its police officers, agents, officials or employees for any injury, loss or damage which may be suffered by the undersigned by reason of the negligence or alleged negligence, including willful and wanton negligence, of the Village of Gurnee or any such police officer, agent, official or employee of the Village of Gurnee.

Nothing herein contained shall confer any rights on the undersigned, and the Village of Gurnee reserves the right to manage, revise or terminate the program described above at any time and for any reason it deems sufficient.

Should any section, paragraph, clause, sentence or provision of this waiver be adjudged by a court of competent jurisdiction to be invalid, such decision shall not affect, impair, invalidate or nullify the validity of the remainder of the waiver as a whole, or any part thereof, other than the part so adjudge to be invalid.

"Honor - Integrity - Service"

This agreement shall be binding on and inure to the benefit of the heirs, executors, administrators, successors and assigns of the respective parties herein.
