AN ORDINANCE ADOPTING THE 2024 EDITION OF THE INTERNATIONAL SWIMMING POOL AND SPA CODE, AS MODIFIED AND WITH SUPPLEMENTS, PROVIDING PENALTIES FOR VIOLATIONS AND AMENDING CHAPTER 18 AND ADDING ARTICLE XI TO THE GURNEE MUNICIPAL CODE

WHEREAS, The President and Board of Trustees of the Village of Gurnee have determined that it is in the best interest of the Village of Gurnee to adopt the 2024 Edition of the Swimming Pool and Spa Code as modified, as the standard for establishing minimum requirements for the design, construction, alteration, repair and maintenance of swimming pools, spas, hot tubs, and aquatic facilities herein provided; for the issuance of permits and collection of fees thereof; and each and all of the regulations, provisions, penalties of the Swimming Pool and Spa Code within the Village of Gurnee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF GURNEE, LAKE COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, AS FOLLOWS:

SECTION I: That Chapter 18 Article XI, entitled "Swimming pool and Spa Code" of the Gurnee Municipal Code is hereby adopted and entitled Gurnee Swimming Pool and Spa Code, to provide as follows:

CHAPTER 18 ARTICLE XI. GURNEE SWIMMING POOL AND SPA CODE

SECTION II:

Sec. 18-550. Adoption.

The regulations, conditions, definitions, and stipulations concerning minimum requirements for the design, construction, alteration, repair and maintenance of swimming pools, spas, hot tubs, and aquatic facilities, as set forth in the 2024 International Swimming Pool and Spa Code, with modifications and supplements set forth in section 18-501, are hereby adopted and made applicable, subject to exceptions made in this article, to all existing or proposed identified construction, within the corporate limits of the village.

SECTION III:

Sec. 18-551. Modifications, supplements and exceptions.

The following sections of the 2024 International Swimming Pool and Spa Code, are revised as follows:

CHAPTER 1 ADMINISTRATION

SECTION 101 GENERAL

Section 101.1 Title. Insert "Village of Gurnee" as name of jurisdiction.

SECTION 102 APPLICABILITY

Section 102.7.1 Application of the International Codes. Replace reference to International Residential Code in this section and any other locations with the "Gurnee Residential Code for One- and Two-Family Dwellings."

SECTION 103 CODE COMPLIANCE AGENCY

Section 103.1 Creation of Enforcement Agency Insert "Community Development" as name of Department.

SECTION 104 DUTIES AND POWERS OF THE CODE OFFICIAL

Section 104.2.4.1 Flood hazard areas. Replace reference to International Building Code in this section and any other locations with the "Gurnee Building Code."

SECTION 112 MEANS OF APPEALS

Section 112.1 General Replace entire section as follows: "In order to hear and decide appeals of orders, decisions or determinations made by the *Code Official* relative to the application and interpretation of this code, the seven members of the Gurnee Village Board shall serve as the Board of Appeals. The Board shall render all decisions and findings in writing to the appellant with a duplicate copy to the *code official*."

Section 112.3 Qualifications Delete this section in its entirety.

CHAPTER 3 GENERAL COMPLIANCE

SECTION 302 ELECTRICAL, PLUMBING, MECHANICAL AND FUEL GAS REQUIREMENTS

Section 302.5 Backflow Protection. Replace reference to International Plumbing Code with Illinois Department of Public Health Plumbing Code and in all other sections of this code.

SECTION 306 DECKS

Section 306.1 Wastewater Discharge. Replace reference to International Residential Code with the "Gurnee Residential Code for One- and Two-Family Dwellings." Replace reference to International Building with the "Gurnee Building Code" and in all other sections of this code.

CHAPTER 5 PUBLIC SPAS AND PUBLIC EXERCISE SPAS

SECTION 507 WATER SUPPLY

Section 507.1 Water Temperature. Remove entire section and replace with: "Shall meet the Illinois Department of Public Health Plumbing Code."

SECTION IV: All parts of ordinances in conflict herewith, but only to extent of such conflict, are hereby repealed.

SECTION V: Nothing in this Ordinance shall be construed to affect any suit or proceedings pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action arising, acquired or existing under any act or ordinance or portion thereof hereby repealed or amended by this ordinance; nor shall any just or legal right, claim, penalty or remedy of any character of the corporate authority existing on the effective date hereof be lost, impaired or affected by this Ordinance.

SECTION VI: If any provision, clause, sentence, paragraph, section, or part of this ordinance or application thereof to any person, firm, corporation, public agency or circumstance, shall, for any reason, be adjudged by a court of competent jurisdiction to be unconstitutional or invalid, said judgment shall not affect, impair or invalidate the remainder of this ordinance and the application of such provision to other persons, firms, corporation, or circumstances, but shall be confined in its operation to the provision, clause, sentence, paragraph, section, or part thereof directly involved in the controversy in which such judgment shall have been rendered and to the person, firm, corporation, or circumstances involved. It is hereby declared to be the legislative intent of the corporate authorities that this ordinance would have been adopted had such unconstitutional or invalid provision, clause, sentence, paragraph, section, or part thereof not been included.

SECTION VII: This ordinance shall be in full force and effect on March 1, 2026 and after its passage, approval and publication as required by law.


SECTION VIII: The Village Clerk is hereby directed and ordered to publish this ordinance in pamphlet form as required by Law.




