#### **1.0 INSTRUCTIONS & CONDITIONS**

The specifications provide technical guidelines and details for the Village's 2017 NETWORK EQUIPMENT PROJECT. The specifications are an integral part of the Village's formal Request for Proposal (RFP) dated March 10, 2017. All responders are required to review this document in detail and acknowledge their understanding of the technical aspects of this project in order to be considered a responsible Bidder.

#### **1.1 Project Overview**

The Village of Gurnee owns and operates a number of in-building wired and wireless Local Area Networks (LAN), a Cisco Unified Communications system, and a Metropolitan Area Network (MAN) including fiber and wireless point to point connections. The Village's Police Station Facility includes a 9-1-1 Communications Center. The Village is interested in expanding these systems as follows:

- Cisco Routing, Switching and Firewall Equipment for connecting the Gurnee & Zion Police Stations related to Dispatch Consolidation
- Cisco Switching Equipment for Gurnee Public Works including 10Gb connection support
- Cisco Switching Equipment for Gurnee Fire Station #1 including 10Gb connection support
- Cisco Firewall Equipment for Internet Connection
- Cisco IP Phone Sets for existing Cisco Unified Communications Manager
- Cisco Routing Equipment for Public Works SCADA Operations

#### **1.2 Bidder Requirements**

It is the policy of the State of Illinois that a wage of no less than the general prevailing hourly rate as paid for work of similar character in the locality in which the work is performed will be paid to all laborers, workers, and mechanics employed by or on behalf of any and all public bodies engaged in public works. Bidder must be in compliance with the Equal Employment Opportunity Clause and the Illinois Fair Employment Practices Act.

The Village of Gurnee reserves the right to waive any or all technicalities, to reject any or all bids and to make an award in the best interest of the Village.

Staff will recommend a vendor to be recommended to the Gurnee Village Board for award based on the proposal which is determined to be the most advantageous to the Village of Gurnee in consideration of price, completeness, content, experience and the Vendor's ability to perform.

Each Proposer shall identify any information submitted in the request for proposal process that is considered by it to be confidential or proprietary. Each Proposer, by its submission of its Proposal, acknowledges that the Village is subject to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq., and that no disclosure made in good faith by the Village pursuant to such Act shall be deemed to violate this section

All proposed equipment will be new. Only bids submitted by manufacturers authorized resellers will be considered.
