Chief Kavanaugh stated that the beacon for Fire Station #3 has been installed.

Chief Kavanaugh stated that so far in 2022 there is a 200 call increase in calls from this time last year and the District is back to pre-pandemic levels. The calls still include responses for complications due to Covid-19.

Chief Kavanaugh stated there was one fire in the District located in Park City. The rapid response kept the incident to a singe unit and there were no injuries.

Attorney's Report:

Ms. Trela stated that a letter had been received and forwarded to Trustee Wattleworth from Striker the company that provided the heart monitors that were part of the Covid relief award to the District. A rebate is being sent in the amount of \$552.52.

a. Ordinance 2022-O-01 FY2022-2023 Budget & Appropriation.
