Dear Business Partners:

Today, Governor Pritzker and the Illinois Department of Public Health (IDPH) <u>announced</u> that COVID-19 resurgence mitigations will be implemented in the North Suburban Region 9, which includes all of Lake and McHenry Counties, beginning 12:01 a.m. on **Saturday**, **October 31, 2020**.

Region 9 has seen a 7-day rolling average test positivity rate of 8 percent or above for three consecutive days, which exceeds the thresholds set for establishing mitigation measures (Tier 1) under the state's <u>Restore Illinois Resurgence Plan</u>. Region 9 restrictions will remain in effect until the region's positivity rate averages less than or equal to 6.5% over a 3-day period.

Tier 1 mitigation measures taking effect in Region 9 on October 31 include:

#### Bars

- No indoor service
- All outside bar service closes at 11:00 p.m.
- All bar patrons should be seated at tables outside
- No ordering, seating, or congregating at bar (bar stools should be removed)
- Tables should be 6 feet apart
- No standing or congregating indoors or outdoors while waiting for a table or exiting
- No dancing or standing indoors
- Reservations required for each party
- No seating of multiple parties at one table

#### Restaurants

- No indoor dining or bar service
- All outdoor dining closes at 11:00 p.m.
- Outside dining tables should be 6 feet apart
- No standing or congregating indoors or outdoors while waiting for a table or exiting
- Reservations required for each party
- No seating of multiple parties at one table

#### Meetings, Social Events, Gatherings

- Limit to lesser of 25 guests or 25 percent of overall room capacity
- No party buses
- Gaming and Casinos close at 11:00 p.m., are limited to 25 percent capacity, and follow mitigations for bars and restaurants, if applicable

Other business types will continue to operate under <u>Phase 4 guidelines</u> with no mitigations. This <u>Frequently Asked Questions</u> document provides further guidance.

I thank them for their commitment and encourage residents and businesses to continue sampling our fantastic variety of local cuisine through carryout, delivery, and outdoor dining!

### Small Business Assistance

<u>Business Interruption Grants Program (BIG)</u> – Round 2 <u>applications</u> are open; grants will be awarded on a rolling basis. Businesses impacted by Tier 1 mitigations, such as restaurants, will receive an expedited review going forward. All potential applicants are encouraged to review <u>FAQ's</u>.

#### Economic Injury Disaster Loans (EIDL)

While the EIDL Advance is no longer available, all Illinois businesses can still apply for the EIDL loan. The interest rate for this 30-year loan is 3.75% for small businesses and 2.75% for non-profits. The first payment is deferred for one year. All potential applicants are encouraged to review FAQ's

### Comcast Rise Grant Program

### IL Dept. of Labor – Back to Business Illinois

Back to Business Illinois is a free, voluntary service to connect small businesses of 250 employees or fewer with consultants who will help them evaluate and address workplace safety and health issues related to COVID-19. The online guidance and education program will emphasize areas including basic infection prevention, physical space modification, infectious disease planning, employee monitoring and workplace flexibility. This is a non-punitive program, and no fines or citations are associated with it. It is designed entirely as a benefit to empower Illinois small businesses to continue operating safely.
