COVID Economic Injury Disaster Loan Updates (EIDL)

The U.S. Small Business Administration (SBA) recently announced enhancements to the COVID EIDL program. Key changes included:

• Increased Cap from \$500,000 to \$2 million: Loan funds may be used for any normal operating expenses and working capital, including payroll, equipment purchases, and debt payment.

- Deferred Payment Period: Repayment need not begin until two years after loan origination.
- Expanded Eligible Use of Funds: Funds will now be eligible to prepay commercial debt and make payments on federal business debt.
- Simplified affiliation requirements: Affiliation requirements now model those of the Restaurant Revitalization Fund.

Business owners that have received previous loans through the SBA's Paycheck Protection Program (PPP), Restaurant Revitalization Fund (RRF), or Shuttered Venue Operators Grant (SVOG) can still benefit from COVID EIDL. The last day for applications is December 31, 2021 but all applicants should file as soon as practicable. To learn more about the application process, visit www.sba.gov/eidl. PPP Forgiveness Portal

The SBA launched a streamlined application portal to allow borrowers with <u>Paycheck Protection Program (PPP)</u> loans of \$150,000 or less through participating lenders to apply for forgiveness directly through the SBA.
