2021 Temporary COVID-19 Outdoor Dining Guidelines

Revised April 27, 2021

- 1. Outdoor dining, including tents, will be accommodated without a permit so long as it is in conformance with the following guidelines and operations are conducted consistent with the public health, safety, and welfare.
- 2. It is the Village's intent at this time to allow outdoor dining areas including tents to remain in use for the duration of 2021 subject to public safety considerations and adequate parking availability for restaurants and neighboring businesses.
- 3. State of Illinois Restore Illinois orders and guidelines must be followed. At present, every region of the State is in Phase 4 of the Restore Illinois Plan, working toward a Bridge Phase.

- Structures that are more than 50% enclosed <u>or</u> are heated require a Village of Gurnee, no-fee
 <u>Temporary Building Permit</u>. Structures and Devices must be shown on permit plans with
 manufacturers' specifications.
- 5. Heating/Cooking Devices:
 - a. electrical devices are permitted if UL listed or UL classified and approved for tent use
 - b. all wiring must comply with 'temporary wiring' provisions of the National Electric Code
 - c. no cords or cables across paths of ingress/egress
 - d. electrical cords and cables shall be protected from damage
 - e. devices must be disconnected for overnight storage
 - f. clearance between devices and other objects e.g. tent sides, tables, must be maintained
 - g. natural gas or propane allowed only in uncovered, open areas
- 6. Outdoor fire pits may be installed, with a separate <u>building permit</u>, in accordance with the 2012 International Fire Code.
- 7. All structures:
 - a. must have adequate ventilation
 - b. materials must have fire-retardant certification
 - c. must be weighted, anchored, secured to the ground
 - d. must withstand wind and snow loads
 - e. entrances & exits must be clearly marked; fire extinguishers on premise
 - f. a single structure may not be used for cooking and dining at the same time
- 8. Discontinue use of structures and devices during severe weather conditions.
- 9. Social distancing in dining and standing areas shall be observed at all times.
- 10. Tables must be spaced a minimum of six feet apart.
- 11. Property owner approval must be secured for outdoor dining areas.
- 12. The restaurant may operate under normal business hours as allowed.
- 13. For current liquor licensees:
 - a. Outdoor bars are not allowed

- b. Outdoor wait stations are allowed to include liquor if staffed at all times and used exclusively by restaurant personnel; patrons may not approach these stands to order alcoholic beverages.
- c. All liquor orders must be served only to seated diners incidental to food service; liquor shall remain at tables and cannot be carried outside the designated seating area.
- d. Pursuant to strict adherence to all State of Illinois Liquor Control Commission guidelines:
 - Liquor "to go" in original containers will continue to be permitted.
 - Cocktails "to go" will be permitted.
- 14. Establishments must provide trash receptacles in the seating area and will be responsible for clearing all trash from the area each night.
- 15. Hand sanitizing stations must be provided in the seating area.
- 16. Outdoor dining is allowed on non-public sidewalks under the following conditions:
 - a. 4 feet of clearance is maintained for pedestrian access.
 - b. Must be located in front of the tenant space associated with the restaurant; if it extends beyond, then written permission should be secured from the affected tenant(s) and landlord.
- 17. Outdoor dining is allowed in parking lot areas under the following conditions:
 - a. The area devoted to outdoor dining shall not exceed 50% of the parking lot area.
 - b. Tables should be located in parking spaces and not drive aisles whenever possible, unless an entire drive aisle and associated parking spaces can be cordoned off in a manner that preserves safe circulation on-site.
 - c. Tents, Tables, or other appurtenances cannot block any fire lanes.
 - d. Cones or other methods should be used to clearly delineate seating areas from parking/drive aisles.
- 18. If a tent is proposed, it must follow the guidelines herein pertaining to Structures.
