
Mayor's Message

A Message from Vice Mayor Tom Hood

Welcome to the first ever Vice Mayor's message. My name is Tom Hood and I was appointed as the Vice Mayor of Gurnee a few months ago while serving as a Village Trustee for the past seven years. The Vice Mayor's position was formed this past year with the purpose of providing support to the Mayor.

While the Gurnee Mayor position is a part-time position, it regularly requires full-time hours (and sometimes more!). That is where I, as Vice Mayor, step in and provide support to Mayor Kovarik. Whether it's leading an occasional Village Board meeting, representing the Village at a business grand opening, meeting with potential developers or collaborating with Village staff, the Vice Mayor position allows the Village to be more responsive, accessible and available to our citizens.



I am one of six Village Trustees that serve a four-year term elected by the citizens of Gurnee. I serve with Jeanne Balmes, Cheryl Ross, Karen Thorstenson, Greg Garner and Quin O'Brien as Village Trustees. Our primary responsibilities as trustees are to provide general direction to the Village in forming an annual budget, deciding issues that come before the Board and setting the general direction of the Village that is carried out by Village staff.

One of the ways that general direction is provided for the Village is through a strategic plan that is approved every five years by the Village Board. This plan guides the Village staff and Village Board on what to focus their efforts upon. The input provided to form the strategic plan is of the greatest importance and is drawn from a variety of sources, one of the most important being the citizens of the Village of Gurnee. In future messages I will be providing more detail on the content of the strategic plan and I will be inviting you to contribute to the formation of the upcoming five-year plan.

Dr. Casey Begins as Woodland's New Superintendent

Dr. Lori Casey officially began her role as the Superintendent of Woodland District 50 on July 1, 2020, after serving as Acting Superintendent since earlier this spring. Stepping in to such an important leadership position at the same time a global pandemic completely changed everything we knew about education was a daunting task. Luckily Dr. Casey has lived in this community and worked in this district for more than 20 years, and has built relationships with Woodland staff, students and families, making the transition easier despite these very uncertain times.

Dr. Casey began her career in education at the Special Education District of Lake County. From there, she went on to work with children who have learning disabilities and social emotional disorders at Northwood Junior High

in Highland Park. She then went to Hawthorn Primary in Vernon Hills to work as a diagnostician and teacher of first and second grade children with learning disabilities, and then as a supportive programs teacher and coordinator at Hawthorn Junior High School.

The position of Education Supervisor for Woodland Middle School brought Dr. Casey to District 50. After that, she became the assistant principal at Elementary East and principal at Woodland Primary. Before becoming Superintendent in July of 2020, she served in the role of Associate Superintendent of Education for 10 years.

Dr. Casey has been awarded the Special Education District of Lake County Outstanding Educator of the Year, Walmart Teacher of the Year as well as a commendation from the Gurnee Police Department for her work in relation to school safety. She serves as a Board Member for the Exchange Club of Gurnee as well as Warren Township Healthy Communities Healthy Youth.

While the 2020 school year will be anything but normal, Dr. Casey knows that Woodland is powered by a special team of people cultivating a #LifeintheW spirit for the entire learning community. It is not the physical school buildings, but the people and the relationships that build strong educational experiences for our Wildcats. She stands firm in her belief that we will all get through this together, even if we must stay apart temporarily.

Woodland Remote Learning 2.0

The Woodland District 50 Board of Education recently approved the plan for Woodland to return to Remote Learning 2.0 for the 2020-2021 school year. Coming to this decision was not easy, but the safety of our staff and students is something we take very seriously, and this is the safest option for the start of the school year during a global pandemic.

One thing we learned early on in our response to COVID-19 is that this is a very fluid and rapidly changing situation. We began actively planning for the next school year in May, and the return to school plan changed and evolved nearly every day. While we had hoped to bring students back in-person to some extent, it became clear that we could not follow every protocol and procedure outlined in state health guidance to develop a plan that was safe for everyone. With more than 5,500 students and 850 staff members moving through four school buildings each day, physical distancing and managing the quarantine and contact tracing requirements would be nearly impossible. We could potentially have hundreds of students, teachers and staff members quarantined for up to 14 days at various points throughout any given month and the continual interruption would have a serious and negative impact on our ability to provide students with a consistent high-quality learning experience.

The Woodland Remote Learning 2.0 plan is a welcome relief for some families, and a difficult change of course for others. We hope this plan is temporary and we can return to in-person school in the fall because we miss our students and we crave that return to normal like the rest of our community. But just because students will not be on buses and in buildings at the start of the school year, doesn't mean school isn't in session. Woodland staff and educators will be working diligently to provide a rigorous education, with



clear expectations, live instruction, and meaningful connections among teachers and students. Students will be expected to attend classes, complete all assignments, and work with their teachers and classmates just as if they were in a traditional classroom. In addition to providing an education for students, Woodland staff will continue to support our students in other ways. Many related school services will still be available while we are in remote learning such as technology assistance, food service distribution, and social-emotional support (e.g. counseling, behavioral support, crisis intervention).

Woodland will continue to work with other school districts in the area, community partners, child care providers and other support service providers to help build a network of support for our students and families. Nobody should have to navigate this global pandemic alone.

Woodland opened the Teacher of the Year nomination period in January. Staff, students, families and community members were invited to submit nominations for teachers and staff that go above and beyond to support Woodland's learning community and truly live #LifeintheW. We received nearly 500 nominations in a matter of a few weeks.

Return to Remote Learning

Despite months of planning for a full or blended return, it was determined that a continuation of remote learning would be the best choice for the start of the 2020-21 school year. Although this is not what most wanted, this option assures the lowest risk and the most safety for students, staff and our community. Many factors including availability of staff, positivity rates, guidelines provided by the Illinois Department of Public Health and the Illinois State Board of Education, and transportation influenced the decision. With the ever changing nature of the situation, we did not feel confident that we could create a sustainable system with the necessary continuity of instruction and stability of staff with the guidelines provided. It is our hope that we will be able to return to either the blended or full return models for the second quarter with a decision being made as we move towards mid-October.

The Gurnee area school districts have been in constant contact to create programs and plans that will work well throughout our community, especially for families with elementary and high school students. Gurnee School District 56 families completed surveys to indicate what worked and did not work in the spring. The planning process that occurred this summer took these results into account. The remote learning program will not only be longer in time per day, but it will be more rigorous. There will be a mix of online and paper/pencil tasks used in most classrooms. Students will be working with their teachers through their iPad, but will also be reading novels, working in workbooks, utilizing math manipulatives, textbooks and other resources teachers require. Students will be provided with supplies, books and iPads prior to the start of the school year. Parents will find a simplified set of platforms and support systems in place for help.

The abrupt end to in-person school has created the need and opportunity for us to think about education from the viewpoint of students and families more than ever. While we expect this experience to look and feel different than last spring, we will continue to work on improvements throughout the new year.

Gurnee District 56 has developed a five-year Capital Improvement Plan for maintenance of our buildings. The five-year plan includes roof replacement, carpet replacement, an upgrade to the software that controls our energy usage, and other maintenance items to achieve the most efficient use of energy. The district plans on including the costs for these projects in its annual budget over the next five years.

Student Programs

Spaulding Library Space

Spaulding School, a District 56 Pre-K thru 2nd grade building, is the site of a construction project renovating the library for the new school year. The library is most often the hub of the school and can set the tone for the building. Library services have transformed over the past ten years to include not only digital content, but to be a space for the creation of content and hands on learning opportunities in Maker Spaces. These are not intended to be a quiet room to find a book and leave. They are now used for activities, to support instruction in the classroom and to provide a space for students to think differently. Spaulding School is the last of the Gurnee District 56 facilities to update their library space and create a Maker Space for students.

The primary students were key in the development of the design for the updated library space. Students from all grade levels participated in planning meetings as well as teachers, parents, administrators and architects. The students identified characteristics of what they wished they had available to them in their library that would make them excited and engaged. Trends and themes were identified leading to the concept for the new space.

The end result is the creation of Spaulding Woods. Students' drawings presentations spoke to their love of the outdoors, animals and adventure. The outdoor theme will be evident throughout the space where a river runs past the campground and treehouse that are creative cubbies for kids to curl up with a good book. Log cushions for seating on the grass (carpeting) create special group teaching spaces. Graphics and a new color scheme will completely change the tone of the library, with bright and bold colors, and should peak the interest of the students as they walk by this new space. This new space will truly be a reflection of the students in our school.

This space is expected to be ready for the students on the first day of school. Unfortunately, due to the COVID-19 virus, the students will only get a peek though pictures at this time. We cannot wait to get students in the new space and see their reactions!

The Cost of Poverty Experience

This past spring, the staff of Gurnee District 56 hosted the Cost of Poverty Experience. This simulation activity placed each person in the role of an individual working their way through one month of living in poverty. Staff were placed into various family units such as single parent, two children, two parent, four children, elderly couple, etc. Each family's scenario placed them in the position of needing to utilize community resources to make it through the month on an income at the poverty level. They were required to pay rent, buy food, go to school, and manage transportation all while meeting deadlines.

This was an opportunity for our staff to get a small glimpse into the lives of some of our students and families. One in three students in our classrooms is considered to be living in a low income home. Recognizing, understanding and empathizing with the challenges that they face on a daily basis is important because all of our students need support in order to be the best learners they can be.

This event also brought members of our community together to share in the experience. Volunteers gave up their own time to work at the simulation stations acting as employment office representatives, bankers, mortgage and rent collectors, police officers and representatives from other community resources. We were so excited to see staff and community volunteers from Living Justly, Warren High School, Woodland School District, Warren Newport Library, Gurnee Park District, the Gurnee Village Board, the District 56 Board of Education and Mayor Kovarik volunteering their time to increase awareness.

At the conclusion of the event, participants in the experience shared many take-aways. They reflected on being evicted, leaving a loved one in jail because they knew where they were and that they would be fed, and the frustrations of waiting in line for help when feeling pressured by a deadline. For some, this experience brought painful memories of their own experiences with poverty. For others it was very close to their current reality. "We need to do better," and "I was so stressed," were common comments. This was a half day simulation for our staff that led several to take time to recognize and reflect upon the fact that poverty is an everyday reality for many of our students.

This activity was just one step District 56 has taken to improve our understanding and relationships with our students and the community as a whole. In trying times such as these, it is increasingly important for all of us to learn what it is like to walk in the shoes of another and take the time to do what we can to make our journey together a better one.



Warren Township High School District 121

Remote Learning to Start the 2020-2021 School Year

At its July 21, 2020 meeting, the District 121 Board of Education approved a return to school with our fully remote learning plan, at least through Friday, October 2. Our first day of remote instruction will be on Monday, August 17. We will continue to monitor guidance from the Illinois State Board of Education and the Illinois Department of Public Health and Lake County Health Department and hope to have our students back with in-person instruction as soon as we are safely able to do so. Regardless of our instructional platform, we are committed to maximizing the growth and achievement of every student through rigor, support and innovation. We believe in the principle that "we are in this together." We are committed to hold all students to high academic standards, build positive and supporting relationships, create engaging learning experiences, support social and emotional needs, embrace the responsibility and accountability to our community and emerge from this pandemic stronger than we began.

Dual Credit and Transitional Credit Course Expansion

A key focus of our strategic plan the past few years has been to increase access to dual credit courses for students at Warren Township High School. Research has proven that high school students who are exposed to college-level coursework, such as dual credit or Advanced Placement courses, are more successful in their postsecondary education. Dual credit courses are different from advanced placement (AP) courses. Students enrolled in AP courses take an end-of-course exam in the spring, and if they earn a score of three (3) or higher, then they are awarded credit from most colleges/universities. Students enrolled in dual credit courses are subsequently enrolled at College of Lake County (CLC). Upon successful completion of the course, students earn high school credit through Warren and college credit through CLC.

Warren has traditionally offered dual credit through our Honors Earth Science course, and students enrolled at the Lake County Tech Campus are able to earn dual credit in their areas of study. Dual credit information for the Technology Campus is available at: https://www.techcampus.org/. Beginning with the 2020-21 school year, WTHS is expanding our dual credit offering to include Honors Language and Composition. This course is offered in our English Department to senior students who successfully completed English III or Honors American Studies.

We are also offering transitional courses in English and Math beginning in the 2020-21 school year. Transitional courses allow students who successfully complete the course to enroll directly into credit-bearing English and Math courses upon enrolling at CLC, without having to take a placement exam. Students enrolled in Language and Composition and Preparatory Math and Statistics will complete a curriculum focused on strengthening their skills to be considered college ready by CLC.

Math teacher Laura Oeffling has been voted by her colleagues as Warren Township High

School's 2019-20 Gurnee Teacher of the Year. Each school year, the Village of Gurnee recognizes three Gurnee teachers, including one from Warren Township High School District 121, Gurnee School District 56 and Woodland School District 50. "Students enter, often knowing nothing about a topic—say, for example, the Fundamental Theorem of Calculus—and then leave 45 minutes later with a good working understanding of it. That is thrilling," said Oeffling.

Oeffling believes math is its own language of sorts, and once students are taught how to speak it, a whole new world can open up for them. She also believes that organization and preparation are the most important tools in the toolbox of success, both in and out of the classroom.

"Laura is the role model for student-centered teaching," said Dr. John Ahlgrim, Warren Township High School District 121 Superintendent. "The time and commitment she dedicates in and out of the classroom to help her students reach their potential on an individual basis is second to none. We are so proud to help recognize her as our Gurnee Teacher of the Year."

"I understand that some kids will use math in their future careers and others will not. But whatever their future holds, I hope that one thing they all take away from their time in my math class is the knowledge of what it feels like to be really challenged and the confidence to persevere, work through it and overcome," Oeffling said. "Above all, this is the skill I want them to all walk away with for life."

Oeffling holds a bachelor's degree from Marquette University and a master's degree from DePaul University, both in mathematics education.

District Finances

Referendum Planning Efforts Postponed

This past February, Warren Township High School District assembled a Citizen Task Force comprised of business, civic, and educational leaders to evaluate the District's funding challenges and proposed solutions.

What the Task Force members learned at the first meeting is that compared to other Lake County high school districts, WTHS receives the least amount of federal, state and local tax dollars. In fact, the District's tax rate is among the lowest of its peer districts, with some districts having access to more than twice the amount of local funding.

Given the District's current level of funding, and the need to balance its budget each year, more than 40 teacher and staff positions have been eliminated in the past five years. And without additional revenues, continued staff reductions and other cuts will be necessary, negatively impacting programming, student services, and class sizes.

Due to COVID-19, the Citizens Task Force's planning efforts came to an abrupt halt in early March. Hopefully, the Task Force will be able to regroup early this fall to continue vetting possible funding solutions.

After the Task Force fully weighs in, WTHS plans to roll out a comprehensive public engagement program starting in late September or early October. The District seeks to allow the entire community to provide their thoughts and recommendations on possible funding solutions that the Task Force helps craft. Public outreach efforts will likely include in-person and/or virtual community information meetings, online surveys, a public opinion mail survey, and other strategies for gathering public input.

The Board of Education understands the challenges our community faces due to the pandemic and stands committed to only pursuing funding solutions that it is confident our community will support. Nothing is set in stone until we gather additional public input.

The solar project, identified in a 2018 bond issuance, is distinguished as one of the largest for an Illinois school district and will generate enough electricity to account for nearly all the electricity needs of the Almond Campus — an estimated \$300,000 annually. The new ground-mounted solar facility is located on the south end of the Almond Campus, along Gages Lake Road.

Gurnee Park District Financial Updates

It is a priority of Gurnee Park District to sustain long term financial strength while providing the many parks and activities residents have come to enjoy. Like many businesses, Gurnee Park District had seen a great deal of impact from COVID-19 closures. The District is heavily reliant on program fees which usually make up 55% of the budget. Due to COVID-19, most programs are on hold or are being offered at a much lower capacity. As we have entered into the new fiscal year (2020/2021), we had to modify our budget considerably. Below is a snapshot of our budget from last year (2019) versus what it is currently with the impact of COVID-19.

The District is an annual recipient of the GFOA award for its Comprehensive Annual Financial Reports as well as its annual budget and we are confident that we will continue to receive these awards even during these challenging times. The District also maintains an AA+ bond rating.

Even during these challenging times, Gurnee Park District strives to ensure financial stability while supporting existing and future infrastructure as well as continuing affordable recreational programs and services.

Village of Gurnee

Knowles Road Water Tower

The Village of Gurnee is close to finishing the construction of the Knowles Road Water Tower after the project planning began in 2018.

This project was started following the removal of the Old Grand Water Tower #1, one of the five above ground water storage facilities maintained by the Village of Gurnee. Due to this facility being taken out of service, the total storage capacity dropped from 6.2 million gallons to 6.0 million gallons, which is equal to 1.7 days of average consumption.

The Village also identified the need to improve water pressure and reliability for some residents. Although the average water pressure throughout the Village is between 70 and 80 pounds per square inch, the western limits of the town have experienced lower water pressures between 30 and 50 pounds per square inch. This difference is due to the western limits of the Village having the highest elevation of the grade above sea level.

In order to improve water pressure, the new water tower was built on the highest elevation in the Village to utilize gravity to pressurize the water distribution system. It was built on a vacant parcel that was owned by the Village of Gurnee, near the end of Knowles Road, adjacent to Rollins Road. Along with this increased water pressure, the Village also saw additional water storage, increasing the total capacity to approximately 8 million gallons, or 2.2 days of average consumption.

addition to the construction of the Knowles Road Water Tower, the Village made additional improvements the Village's water distribution system by constructing a booster pump station and a steel prefabricated pressure reducing valve stations located on Almond Road and Foxworth Lane. These improvements financed primarily through a loan from the Illinois Environmental Protection Agency's Drinking Water Revolving Fund, State administered by the Illinois Environmental Protection Agency. The \$6,132,208 loan has an interest rate of 1.84% and will be repaid over 20 years.
