 6-lot subdivision. The subject property is zoned R--3 PUD—Single-Family Residence as a
 Planned Unit Development and consists of approximately 1.88 acres and is located at 4261
 Chatham Avenue.)
- 8. Informal Review: Bernard Property in East Grand Gateway Overlay District
 (Mr. Bernard is requesting feedback on a proposed residential development located in the East Grand Gateway Overlay District. The 3.22 acre property is generally located on Waveland and Grand Avenues and is zoned both C/B-2 EGG—East Grand Gateway Overlay District and R-4—Two-Family Residence District.)
