4. **Public Hearing: Zoning Map Amendment (Rezoning) for Roger Bury**  
(Roger Bury is requesting to Rezone a 0.276 acre parcel from R1: Residential - 1 in unincorporated Lake County to R-3 Single Family Residence District in the Village of Gurnee. The subject property is located approximately 125 feet west of the Green Bay Rd & Crescent Ave intersection at 12966 W. Crescent Ave.)
5. **Public Hearing: Revised Heritage Woods of Gurnee, LLC (3775 Grand Ave)**  
(Heritage Woods, LLC is seeking approval of revised applications, including a revised site layout and associated plans for the following:
  1. Rezoning from C/B-2 EGG, East Grand Gateway Overlay District and R-3, Single-Family Residence District, to C/O-1 PUD, Restricted Office District;
  2. Request for Waiver of Certain Preliminary Planned Unit Development application material submission requirements (Tax and School Impact study);
  3. Special Use permit for a Preliminary Planned Unit Development application to develop the subject property (approximately 3.8 acres) with a three-story Senior Supportive Living Facility, including certain departures from the Village's codes, ordinances, rules and regulations;
  4. Special Use permit to allow the Senior Supportive Living Facility, more formally defined within the Zoning Ordinance as a Geriatric Center / Institution for the Care of the Aged; and
  5. Such other relief as may be necessary to accomplish the applicant's development plan.The subject property is located at 3775 Grand Avenue which is generally the southwest corner of Grand Avenue and Waveland Avenue.)
