Period Ending September 30, 2018

Gosnell outlined the total revenues at \$550,948.52. Not included in there is the September 9-1-1 surcharge distribution due to the state changing the account when they changed an unrelated ambulance billing account. The money was put into and later located by staff in the ambulance billing account and will be transferred back. Total expenditures came out to \$295,758.55, for a net increase of \$255,189.97. Ending book balance is \$917,778.99. We are in good shape balance wise.

Changes in Annual Maintenance Fees

Upon review of the maintenance fees it was found that the Interoperability Server Application was no longer needed and thus retired. This resulted in a yearly savings of just under \$10,000.00 and the item removed from maintenance.

Chicago Communications has all of the equipment and has begun the programming process and will be looking to field deploy that as the microwave work comes along. This should be deployed in parallel and result in no down time.

This resulted in everyone being on the same page and everyone aware of the Beach Park Water Tower entry/work requirements.
