#### **Treasurer's Report**

Period Ending January 31, 2020

Gosnell highlighted total revenues of \$607,437.01 and a payment came in February  $1^{st}$  from 9-1-1 surcharge leaving the revenues actually at \$688,511.00. We are currently at 75% of the surcharge for the year. Total expenditures \$440,994.53. The ending fund balance currently at \$1,319,920.02, which matches the bank statement.

#### **Communications Statistics**

November 2019, December 2019, Calendar Year 2019, January 2020

Brunell highlighted the report is slightly different in format. In highlighting the 2019 year end statistics, the overall total CAD events were down 2.9%. Fire calls were up about 5.1% with Gurnee being up about 1000 CAD events from the year prior. Total calls processed were up 1.63 %.

#### Statewide 9-1-1 Administrator's Office

2019 Annual Financial Report (AFR)

Velkover thanked Gosnell and Brunell for working on the filing. It was filed after 2 attempts and accepted by the State.

#### Illinois NG9-1-1 Implementation

Velkover went through the minutes for the State 9-1-1 Advisory Board. They have an RFP for equipment that they rejected and they are rebidding that. That is due back February 10<sup>th</sup>. Their GIS work statewide is progressing nicely. Lake County appears to be leading the state in the data collection effort.

#### **Emergency Medical Dispatch (EMD)**

Priority Dispatch Pro QA Medical Software Project

Velkover asked Brunell to update the status of the project. The installation was completed and he advised they went live on January 28<sup>th</sup>, 2020. There is a final training session being completed today. ProQA has begun the EMD review and it has come back very positive so far. ProQA advised we are the highest compliance score agency they have ever had and Brunell attributed this to Shift Leader Wendy Mann for her work and organization on this project. Henderson asked if Gurnee was doing any public education on the questions being asked of callers. Brunell advised there was a press release and social media posting completed. It was requested if this information could be shared with Zion PD so they can do the same.

#### **CAD System**

Tritech ProQA Paramount Interface EMD

This was completed and the system went live on January 28<sup>th</sup>. Mann advised that during this update PSSI also provided us the RapidSOS CAD integration to better map 9-1-1 calls.

#### **Radio Systems**

Consolidated Quad 1 & Gurnee Fire Radio System Implementation – 2 Year Equipment Plan

Progress continues on the project. Beach Park Fire station 1 site is fully integrated in. The remaining sites are Zion Station 1, Winthrop Harbor Public Works. There were some equipment needs that were identified so a plan was created for any long term needs. Information was included in the packet on the proposal.

Zion Police UHF System Operation / Starcom 21 Field Testing

Brunell and Henderson have been working on this project. Brunell advised that a planned testing will be completed this week with Starcom cache radios. Henderson is pursuing come grant money to defer the cost of purchasing radio equipment.

Final Regional 9-1-1 Consortium Concept of Operations and Implementation Plan Update on Lake County CAD/RMS/JMS Consultant RFP

A copy of the report was included in the packet. An upcoming informational meeting will be this upcoming Thursday to go over the report and complete a question/answer session.

#### **Budget Committee Report – Proposed Fiscal Year 2020-2021 Budget**

Velkover Gosnell, Lewis, Kavanagh and Brunell all collaborated on this project. Gosnell highlighted revenues of \$895,000.00 vs \$875,000.00 last year. The difference is we are earning more interest. The 9-1-1 surcharge was left flat just to be conservative with that number. On the expenditures side, for total expenditures of \$734, 907.35. The Gurnee side \$539,830.00. A majority of the largest line items are maintenance agreements. In the Emergency Backup line item there is a 3<sup>rd</sup> backup for the communications center that is a 50/50 split with the JETSB and Communications budgets. The first annual maintenance for the ProQA software is now budgeted for. Under radio systems equipment there is \$45,000.00, at least \$23,000.00 will need to be added to accommodate the Knowles Rd water tower radio site that was presented earlier. A motion can be made under business items to add this in. Under maintenance for BlackBoard Connect needs to be increased from \$5000.00 to \$6000.00 based on the latest quote, which can also be added in during the motion. There is \$100,000.00 in for Starcom radios. 3 MDC's are budgeted for as well as for cameras at the fire department. Henderson advised that updated quotes were received for the Starcom radios due to the original ones quoted not being up the needed standards. Gosnell advised that \$10,0000.00 will be added to that during the motion as well. At the end of the year we are projected to end with a surplus of \$160,000.00.
