Troy highlighted the Beach Park site is somewhat redundant. Zion has an 80 ft tower on the east side of town that would benefit both Zion and Beach park. The work entails just placing several antenna's at the location as there is already a cabinet installed at the tower. The expense is minimal for the benefits that will be made.

Motorola Proposal - Console and Core upgrade

Conference call was done with Motorola, Chicago Communications and DSS. Discussion was made about clarifications that needed to be made in the proposal including backhaul details about how our system would connect to Downers Grove. It also included a full accounting of logging recorder changes to cover the new set of channels to record.
