G. NEW BUSINESS

1. Approval of Ord. 2025 – 76 amending Chapter 78, Section 78-105 Subsection (d) of the Gurnee Municipal Code to remove the parking prohibition on Hickory Haven Drive, both sides.

Administrator Muetz said the Village was recently approached by residents of Hickory Haven Drive regarding the No Parking Restriction on the street. He stated based upon information from longtime residents of the street; the No Parking restriction was instituted 20+ years ago to alleviate parking demands from visitors to Lake Carina on the east side of IL Route 21. The Lake County Forest Preserve constructed parking facilities for Lake Carina in 2008, thereby eliminating the necessity for the No Parking restrictions on Hickory Haven Drive. Administrator Muetz stated he advised the residents to start a petition and collect signatures from those in the neighborhood showing their support of removing the restriction. Twenty of the 28 homes signed the petition in support. In addition, the Police and Fire Departments do not have concerns about removing the No Parking designation. As such, staff drafted an ordinance amending the Municipal Code to remove the restriction. He stated it is important to note the 2:00 a.m. to 6:00 a.m. No Parking, as well as No Parking during snow and ice control operations, will remain in effect like all other Village streets.

2. Approval of Ord. 2025 – 77 authorizing an extension of time for a Special Use Permit to allow for the establishment and operation of a "Government Office" on property located at 5626-5652 Northridge Drive, previously granted under Ordinance No. 2023-81.

Administrator Muetz said on November 20, 2023, the Village Board approved a Special Use Permit to allow the Veterans Assistance Commission (VAC) of Lake County to establish and operate a government office on property at 5626-5652 Northridge Drive. He stated the VAC proposes to build a 44,000 square foot multi-use office building on parcels previously occupied by Outback Steakhouse and Joe's Crab Shack. The new building will include one- and three-story sections and will offer programs and services to the veterans and their families. The services include but are not limited to gym/fitness areas for individual or group training, café and kitchen areas, a community hub, office spaces, and conference/board rooms. Administrator Muetz stated Special Use Permits become effective upon submission of a building permit consistent with the Village Board approval. As the funding for the proposed project has been delayed, the Veterans Assistance Commission is requesting an extension to the Special Use Permit granted by Ordinance 2023-81. He stated the VAC is expecting to break ground for the facility in the Spring of 2028. Therefore, the attached ordinance extends the Special Use Permit to the end of March 2028. Administrator Muetz stated by that time, building permits will have been applied for and the requirements of the Special Use Permit activation will have been met.
