 Approval of Ord. 2020 - granting a Special Use Permit pursuant to the Gurnee Zoning Ordinance for 1115 N. Hunt Club Road to allow a ground-mounted solar energy system.

Administrator Muetz stated Woodland District 50 requested this item be tabled while it explores installing the solar array on the roof.

NAY: 0- None ABSENT: 0- None Motion Carried. 2. Approval of Ord. 2020 - 37 authorizing the execution of an Intergovernmental Agreement between the Illinois State Toll Highway Authority, the County of Lake and the Village of Gurnee for improvements to the Stearns School Road Bridge.

Administrator Muetz said the Tollway and Lake County will be working to replace the Stearns School Road bridge over I-94. The ultimate design is a 5-lane cross section (2 of the 5 lanes will be put into service at a future date when Stearns is widened to 2 lanes in each direction). At the July 15, 2019 Village Board meeting a few different pedestrian options related to bridge replacement were discussed. The Village Board preferred adding a sidewalk to the south side of Stearns School Road from North Creek Drive (Gurnee Mills' north entrance) eastward to Lawson Blvd and to maintain the bike path on the north side of Stearns School Road as well. These improvements have been incorporated into the plans and reviewed by all parties involved. The FY 20/21 Approved Budget includes \$1.2 million for this project. The current estimate of cost is approximately \$1.1 million. The terms of the Intergovernmental Agreement indicate a Village payment of 35% due at time of Notice to Proceed (approximately scheduled for November 2020). The second payment of 35% would be due at time of substantial completion (approximately October 2021) and the final payment based on actual contract prices and final quantities due one year after substantial completion of construction (October 2022).

It was moved by Trustee Balmes, seconded by Trustee Garner to approve of Ord. 2020 - 37 authorizing the execution of an Intergovernmental Agreement between the Illinois State Toll Highway Authority, the County of Lake and the Village of Gurnee for improvements to the Stearns School Road Bridge.
