#### 1.0 INSTRUCTIONS & CONDITIONS

The specifications provide technical guidelines and details for the Village's 2020 NETWORK EQUIPMENT PROJECT. The specifications are an integral part of the Village's formal Request for Proposal (RFP) dated February 20, 2020. All responders are required to review this document in detail and acknowledge their understanding of the technical aspects of this project in order to be considered a responsible Bidder.

#### 1.1 Project Overview

The Village of Gurnee owns and operates a number of in-building wired and wireless Local Area Networks (LAN), a Cisco Unified Communications system, and a Metropolitan Area Network (MAN) including fiber and wireless point to point connections. The Village is interested in expanding these systems as follows:

- Replace outdated switching equipment for Fire and Public Works Facilities / Locations
- Replace outdated remote VPN client firewalls supporting fire dispatching
- Provide Layer 3 routing and switching at Public Works Facilities
- Provide Layer 2 switch for Public Works Facilities
- Renew Software Subscription(s) for Firewall URL Filtering, Malware and Intrusion Detection license(s)

#### **1.2 Bidder Requirements**

Each Proposer, by its submission of its Proposal, acknowledges that the Village is subject to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq., and that no disclosure made in good faith by the Village pursuant to such Act shall be deemed to violate this section.

Bids on substitute products of comparable quality and usability will not be considered unless otherwise stated or approved prior to submittal. Specifications for all equipment provided must be submitted. The Village will be the sole judge in determining "equals" in regard to quality, price, and performance. All proposed equipment will be new. Only bids submitted by manufacturers authorized channel partners/resellers will be considered. All products supplied must have a valid software license and be eligible for the full manufacturer's warranty and support.
