

5. Please submit all in one package with a copy of this letter.


The following items must be completed and returned to our office before the referenced file can be processed.

- 2. General Contractor's signature, address, and telephone number required on original *Highway Permit* form as Witness, **in triplicate**.
- 3. *Individual Highway Permit Bond* form requires original signature and execution in the amount of \$15,000, **in triplicate**.
4. Submit six (6) 11"x17" copies of revised plans signed and sealed by a registered P.E. licensed in the State of Illinois.
5. Provide the information required on the enclosed *BSPE 725 Traffic Control Authorization Request* form.
